

THE HONORABLE MARC GROSSMAN

Ambassador Marc Grossman is Vice Chairman of The Cohen Group, a position he held between 2005 and 2011, and since 2013. Between 2011 and 2013, he served as Special Representative for Afghanistan and Pakistan. Ambassador Grossman's dedication to public service is demonstrated by his nearly 30-year career in the Foreign Service, beginning with his first assignment as a Junior Officer in Pakistan, where he served from 1977–1979, and ending as the Department's third ranking official, Under Secretary of State for Political Affairs, a position he held from 2001–2005.

He previously served as the Director General of the Foreign Service and Director of Human Resources from 2000 to 2001. At the direction of the Secretary of State, he revamped the State Department's human resource strategies, including the Department's strategies for training, assigning, and retaining personnel, both at home and abroad.

As Assistant Secretary of State for European Affairs from 1997 to 2000, Ambassador Grossman was responsible for over 4,000 State Department employees posted in 50 sites abroad with a program budget of \$1.2 billion. He played a lead role in orchestrating NATO's 50th anniversary Summit in Washington in 1999 and helped direct U.S. participation in NATO's military campaign in Kosovo that same year.

He was U.S. Ambassador to Turkey from 1994 to 1997. In Turkey, he promoted security cooperation, human rights, democracy, and a vibrant U.S.-Turkish economic relationship. He had previously served as the embassy's Deputy Chief of Mission from 1989 to 1992.

As the Executive Secretary of the State Department and Special Assistant to the Secretary of Sate from 1993 to 1994, he managed operations for the senior State Department leadership. He also served as the Deputy Director of the Private Office of Lord Carrington, the NATO Secretary-General, from 1983 to 1986. A native of Los Angeles, California, he graduated from the University of California, Santa Barbara and later received an M.Sc. in International Relations from the London School of Economics and Political Science. As a result of his outstanding service to his country, he is the recipient of numerous honors and awards. He attained the Foreign Service's highest rank in 2004 when the President appointed him to the rank of Career Ambassador; he received the Secretary of State's Distinguished Service Award the following year. He serves on the Board of Directors/Trustees of a number of non-profit and educational institutions.



PAULA S. JAKUB, RHU

Mrs. Paula Jakub is Chief Executive Officer and Executive Vice President of the American Foreign Service Protective Association (AFSPA). In that capacity she provides strategic leadership that facilitates the development and enhancement of various insurance and specialty programs offered by the Association. The Association administers the Foreign Service Benefit Plan with the United States Office of Personnel Management, as authorized by the Federal Employees Health Benefits law. She is also the Executive Director of the Senior Living Foundation (SLF) of the American Foreign Service, where she provides proactive management to the vital organization solely devoted to helping elderly Foreign Service retirees and widows. In this critical leadership role, she oversees the grant/support functions and key activities that are vital to the continued success of the Foundation. Mrs. Jakub attended Creighton University in Omaha, Nebraska. She has over 37 years of extensive background in the insurance field, having received her underwriting certification from American College. Mrs. Jakub is a Registered Health Underwriter, as designated by the National Association of Health Underwriters. She is formally recognized as a Subject Matter Expert in Federal Health Benefits by the Foreign Service Institute, where she serves on the adjunct faculty. She serves on the Board of the Association of Federal Health Organizations.



KYLE LONGTON, CAE, REBC

Kyle Longton serves as the Chief Operating Officer of the American Foreign Service Protective Association (AFSPA). He oversees all daily operations for the Foreign Service Benefit Plan, AFSPA's health plan administered under contract with the United States Office of Personnel Management. The plan provides coverage to more than 90,000 members around the world and processes claims exceeding \$300 million each year. In addition, Kyle provides executive management of Ancillary Insurance Programs, offering dental, life, disability, and critical illness coverage to AFSPA's members.

Kyle also serves as the Deputy Director of the Senior Living Foundation (SLF) of the American Foreign Service. In this role, he facilitates educational opportunities and manages more than \$600,000 each year in grants to elderly members of the Foreign Service community with demonstrated needs. Kyle holds a Bachelor of Arts degree in International Studies from Centre College of Kentucky and a Master of International Affairs degree from the George Washington University. He is a Certified Association Executive (CAE) as designated by the American Society of Association Executives (ASAE) and a Registered Employee Benefits Consultant (REBC), as designated by the National Association of Health Underwriters (NAHU).



GREG KLINGLER, CFP®, ChFEBC, CFPA

Greg joined Government Employees Benefit Association (GEBA) in 2010. He began with GEBA as the Director of Products and Member Services. He has since transitioned to focusing solely on Wealth Management. Greg has been advising State and federal employees since 2003 and assisting them in maximizing their retirement plans. 




DARLA CLINEDINST RN, BSN
